- v. High proficiency in oral and written English which may be depicted in the documents/reports printed/publication

**The Applicant is required to submit the following;**

- i. Covering letter
- ii. Updated CV
- iii. Detailed Concept Note with methodology
- iv. A statement indicating how the applying consultant is most suitable for the competency

## **Proposal**

The Summary of Proposal/Concept Note should contain the mid-term review of above strategy and future action plan for successful implementation. The proposal should also incorporate road map and time frame with situation analysis, data/information collection & analysis, findings and recommendation..

## **Deliverable:**

Technically refined Final draft of analytical mid-term reports of above Strategies by August, 2021.

## **Consultancy Fee/Remuneration**

The Centre will pay US\$ 2000.00 (per strategy US\$ 2000.00/equivalence in NRs). The Centre will not bear any separate costs
